



# Terms of Use

## Welcome to E-VENTUNE TRADE!

These Terms of Use ("Terms") govern your access to and use of the E-VENTUNE TRADE website (the "Website") and the services we offer (the "Services"). By accessing or using the Website or Services, you agree to be bound by these Terms.

### 1. Eligibility
